Beacon Industries' obligation under this warranty shall be limited to the repair, by Beacon Industries, Inc. or a Beacon Industries, Inc. authorized technician, or exchange of any part of parts which may prove defective under normal service within the time limitations set forth above, and which our examination shall disclose to our satisfaction to be defective. Beacon Industries, Inc. requires the purchaser to send date stamped photographs for initial review of warranty claim products.
