- The BCE-9500 is an impact-style vehicle restraint which combines an advanced communication system with a low-profile carriage and an impact extension bar that accommodates a wide range of lower R.I.G.'s (rear impact guards).
- Fully automatic unit provides Restraining Force in excess of 32,000 lbs.

Easy Installation

- Mounts directly to face of new or existing dock above ground level keeping the motor clear of flooding water and debris.
- Recommended Factory Consultation available for dock heights of less than 48" or 24" deep pits.
- Note: As with all electrical equipment, this unit should not be immersed or submerged. Contact Beacon for alternative solutions.
